Fraser has represented RIAS North on RIBA Council since 2016 and seeks re-election in order to reinforce the work carried out to date. Fraser has represented members views vociferously and has successfully protected the Scottish voting rights on RIBA Council when other regions have lost representation. Fraser was unanimously supported by RIAS Council to continue this role. Fraser respects open and transparent decision making.

Fraser was raised in Dundee before qualifying as an architectural technician with 'Robbie and Wellwood', Broughty Ferry. A BSc Environmental Science and B.Arch (hons) were subsequently achieved at Duncan of Jordanstone College of Art, University of Dundee. During this time Fraser was recognised with the 'Grampian Television Award',

'Robertson Prize for Archaeology' and the prestigious'RIAS Thomas Ross Award' for studies into luminary architect James Marjoribanks MacLaren. These studies were further expanded by qualifying in 2013 with an MA Town and Country Planning.

Following spells at 'Nicoll Russell Studios' and 'James F Stephen Architects' Fraser joined 'Fife Council' winning the 'Scottish Housing & Environmental Innovation Award' in collaboration with 'Kingdom Housing Association'. Election Statement:

Architects are the only construction professionals whose mission is to create a rich, coherent and resonant physical environment. We have the vision to shape the future, and the skills to deliver it. As guardian of the profession, I believe that the RIBA plays a central role in promoting these vital aims, and provides architects with the support they need in practice. On the RIBA Council I will be add my energy to this mission.

I have worked in the East of England for the last fourteen years, and have helped to promote the position of architects and architectural practice at RIBA Branch and Regional level. I was Branch Chair in Norwich from 2011 to 2013 and Regional Chair (RIBA East) from 2013 to 2015.

Since qualifying in the mid 1980's I have experienced many different ways of practicing architecture. I have worked in a large commercial office, a small, design-led studio, a militia-discipline design environment with graphic and industrial designers and I set up and ran my own practice in Central London. I am now a Senior Director in a multi-discipline company that has studios in four locations in the UK, and employs over 80 construction professionals, twenty-five of whom are in our architectural studios. Our work focusses on community-led projects and sustainable living.

My greatest concern after more than three decades in practice has been the diminishing professional standing of architects, our reduction in influence and our concession to other professionals, who have taken over many aspects that were considered to be the architect's role when I first qualified. As a member of the RIBA Council I aim help architects regain their position as thought leaders, and to become a strong voice supporting architects in practice.

I know and understand the needs of architects who practice in the East of England and I want to ensure that their voice is heard at the RIBA's 'top table'.

I believe the RIBA should provide more of an offering for the regions. In Hampshire we are fortunate to have a thriving local chapter. However, there is always room for improvement and for the best practice from each branch to be more widely shared.

I advocate improved sharing of best practice and the creation of event toolkits so member's initiatives can be shared across chapters. All too often an excellent local initiative fails to get wider exposure and therefore does not achieve its potential to the benefit members.

In Winchester I have established a small practice group to support small and sole practitioners. This has quickly grown to include free CPD usually available to larger offices. There is a huge amount of enthusiasm and effort going into promoting architecture at a grassroots level. The RIBA should have a mechanism to support and encourage members initiatives.
