## RIBA Part 3 Professional Examiners

Within the RIBA Description & Regulations for the Recognition of Courses and Examinations in Professional Practice and Management, (Part 3) in the U.K. (see [http://www.riba.org/go/RIBA/Also/Education\\_2416.html](http://www.riba.org/go/RIBA/Also/Education_2416.html)), the RIBA is required to maintain a list of suitably qualified and experienced architects, who are available to act as Part 3 Professional Examiners. This list or database is only to be used for the purposes of administering the Final Examination in Architecture, and will not be disclosed to anyone other than Heads of Schools of Architecture, Professional Studies Advisors, officers of the RIBA or members of the RIBA Education Committee.

The list of Professional Examiners contains two categories:

- Category 1 is for architects who are experienced professional examiners who have examined at Part 3 level on one or more occasions. **(Please complete Pages 1 and 2 and include C.V)**
- Category 2 is for architects (with a minimum of five years practice experience) who have no experience of acting as professional examiners. **(Please complete Pages 1 and 3 and include C.V.)**
