#### **Election Statement:**

I believe that great things happen when we work together: by finding common ground.

The RIBA has been disengaged far too long from its members which diminishes opportunities for architects to effect change: externally within the wider industry and internally by better supporting a profession of inspiring thinkers, change-makers and risk-takers.

I previously served on RIBA Council 2013-2017 as elected student and subsequently Associate member. Having initiated a restructure of Council and increased student voting rights, I then became the first Vice President for student and Associate members and one of RIBA Ambassadors during Jane Duncan's presidency. Now as a chartered architect I believe there is still work to be done and I am set to make a difference.

As YOUR Nationally elected member on Council I will focus on:

- Modernisation of the RIBA: to enable the RIBA to better serve its members whilst being able to adapt and respond to a construction industry in flux. Restructuring Council was the first step, there is a need to review RIBA's role alongside a set of contemporary Byelaws and Regulations.
- A more socially inclusive cohort of architects into and upward through our profession: as part of a larger Trailblazer group I helped establish Architectural apprenticeships as an alternative path to qualification a major development in our profession however, the hard work can't stop here.
- Cross industry collaboration, outreach and research: bringing closer education, practice and other professions to mutually challenge and support each other; to enable people and communities to define themselves and thrive through good design now and far into the future. As board member of Young Architects and Developers Alliance (YADA), I work with developers to champion stories of collaborative project teams, new working methodologies and drivers of business success within the construction industry.

I will push for the following concrete proposals:

#### Technology

- Establish an RIBA Technology Committee
- Publish extensive BIM adoption guidance
- Hold regular free BIM training talks and seminars for members, all around the country
- Hold regular free software and technology training events for members
- Include the basics of BIM in the Part I curriculum
- Create an online hub incorporating access to all member services

#### Affordability

- Implement much bigger RIBA Bookshop discounts for members
- Give student members a 50% discount on RIBA books
- Push for discounts on private software licencing and training for members
- Push architecture schools to give more generous printing and materials allowances Visibility
- Push for the return of proper BBC Stirling Prize coverage
- Push for more television, radio and print coverage of architecture
- Add a public-choice award for the Stirling Prize and House of the Year
- Hold regular RIBA events in Westminster for MPs and policy groups
- Have a stronger presence at all political party conferences
- Ensure the RIBA is the go-to organisation for architecture and planning policy questions

#### **Election Statement:**

We need to restructure the RIBA in order to find it a clear purpose and value:

- 1. Slim down and focus the Institution by fundamentally audit the purpose of the RIBA and it's various offerings.
- 2. Participate in public discourse and news advising on current issues facing the build environment.
- 3. Stop being a facilitator of product spamming and facilitate educational CPDs.
- 4. Focus on networking opportunities with client, local- and national government.
- 5. Champion specific changes to national and local systems, from the NPPF, OJEU, overseas hiring policies etc.
- 6. Re-structure the competition system to work for everyone, not just large organisations amd promote paid competitions. We should not work for free!
- 7. Lobby government to give more power and opportunities to architects through changes to the OJEU system: Paid competition over certain size, run by architects in the Swiss model.

Currently membership value and externally relevant in in decline. The Institution as the voice of architects is silent, resulting in 'Architects punching below their weight' (Chair of Parliamentary design forum, Barry Sheerman MP), despite great challenges revolving around the built environment.

In regulatory matters the RIBA fails. Allowing the National Planning Policy Framework to put Design as core criteria turning the planning system into the architectural police with architect becoming subordinates to whims of un-design-educated bureaucrats. A failure of the constitutional directive of promoting good architecture.

To it's members, it is superfluous and futile. Too many "offerings" already available for free outside the institution. Yet it fails to promote it's architects membership to potential clients, or as sources of solutions for development. The RIBA CPD and 'networking' events are filled with specification salespeople.

The Institute needs to reduce and focus it's function, promote itself and architects, and explore alternatives ways to collaborate with outside enterprise.

#### **Election Statement:**

As architects, we are privileged to have the best job in the world. No other profession encompasses history, philosophy, design, economics and blue sky thinking. But I also believe we can, and should be, bolder. Bolder in the advocacy of our profession and our ability to facilitate change. With over 20 years' experience running an architectural practice working locally and internationally, I would now like to join the RIBA Council to focus on four main issues

#### Planning and the role of the architect

I have been actively involved in planning matters, in different capacities, for over a decade and have witnessed the diminishing role of the architect in the shaping of our urban fabric. Building and design decisions are increasingly dictated by local groups and neighbourhood forums, often run by people with no experience, neither in urban planning nor architectural history.

We cannot stand by and watch this trend develop or we risk becoming no more than pastiche architects, producing colour by number buildings.

#### The effect on smaller practices

The complicated planning process is most detrimental on smaller practices that often lose clients after projects are diluted or scrapped altogether. With impatient clients often gravitating towards more acceptable solutions, producing progressive and inspiring architecture is becoming more challenging.

#### Mentoring and co-operation

The mentoring of younger architects, and the co-operation of architects in our profession, can be greatly improved. I would like to encourage collaboration and co-operation between practices, not only as regards design, but also in the daily challenges of running a business.

#### The role of RIBA

RIBA should strive to be more vocal and more influential in the drafting of government policies. It should support and encourage every type of architect: A place where every architect feels equally supportive and proud to be a member.

#### **Election Statement:**

Architectural education needs greater advocacy. The combined challenge presented by student debt, reduced access for students from lower-income backgrounds, a rising mental health crisis, a curriculum that struggles to produce practice-ready graduates and concerns over gender and BAME representation and LGBT inclusivity mean that the RIBA urgently needs to provide leadership and advocacy for architectural education to ensure the architecture profession it is as diverse as the society it seeks to serve. It means tackling head on the varying forms of discrimination reported in the profession, the need to work towards greater collaboration and reciprocity between education and practice, and to champion the next generation of architects upon whom the profession depends. The RIBA can only achieve these aims provided students', educators and architects work together to develop the strategies and solutions needed to support the profession through the challenging and uncertain times ahead.

INTENTIONS: What I would hope to achieve as a RIBA Council member:

- 1. PARITY IN INTERNATIONAL EDUCATION & LICENSING: increase trans-regional qualification parity and/or affordable conversion qualifications ease of licensing as a means to increase mobility, employment & ensure UK-trained architects and practices are globally competitive.
- 2. EXPANDING PATHWAYS TO QUALIFICATION: Developing new models of (debt-free) vocational training for architects, supporting more diverse pathways to qualification, including an increase in practice-situated, vocational training and apprenticeships.
- 3. ETHICS + SUSTAINABLE DEVELOPMENT PEDAGOGY AND PRACTICE: campaign to commit RIBA to implement recommendations of the commission report and to revise Schools Validation Criteria to respond commensurately to the environmental disaster we are facing as a matter of urgency.
- 5. GENDER PARITY: propose ways to address issues of discrimination, poor retention & low women's representation in the profession. Only 20% of RIBA members are women.

#### **Election Statement:**

As a UK Architect in practise I have been actively involved in the Birmingham Architectural Association and have been involved with the London Chartered Architects Livery Company and RIAS Scotland to promote good quality design, equality and accessibility into the Architectural profession. In the council, I would like to work on five goals

- 1) Raise Architects average salary: Contribute to the incoming RIBA president Alan Jones goal to advocate for widespread fee scales and Architect fee benchmarks, like the Law Society and the Engineering Council. Reasonable fees allow Architects to deliver good design quality and work responsibly within the Standard of Care. Encouragement and support needs to be provided to stop Architects working speculatively for developers without payment or working at risk. Other trades and professions charge reasonable fees and so should architects.
- 2) Protect architects' function not just the Architect title. Design build companies are producing architectural designs without architects, devaluing our work and working unregulated. RIBA must protect the function to safeguard our profession from unqualified design companies.
- 3) Apprenticeships and architectural education: The rising cost of architectural education is increasing inequality. Practical training routes like the long-established Engineering Council apprenticeships has recently started with the RIBA Trailblazer apprenticeships. The goal is to develop and promote the adoption of apprenticeships to widen access to the profession.
- 4) Equality, inclusivity and access. Support the RIBA Schools ambassador programme, Women in Architecture, the RIBA LGBT+community, the RIBA Trailblazers apprenticeship scheme and the Inclusive Architects group for disabled members.
- 5) Ensure RIBA works hard for its members The RIBA Professional training day programmes are expensive and exclusive. Outside London, the RIBA communities need to be supported with access to events and programmes. The RIBA Procurement and members' area can be improved for members to access practise management resources effectively.

#### **Election Statement:**

My primary interest is well designed buildings of which we produced many that have been recognised over the past 30 years. (www.mandp.uk.com) My experience includes 3 years with James Stirling and Partner, teaching at Cambridge, the AA, an RIBA planning policy group member for 4 years, ARG founder member and ACA councillor for 6 years.

Over the past decade or so, the RIBA has lost its way. When I joined in 1980, it set the pace worldwide! This was apparent from my previous experience with German, French and US practice. Gradually, the RIBA stopped supporting Architecture and its own members' interest in thrall to a governmental inspired anti professional trend. I would like to apply pressure from within Council to stem and hopefully reverse this mis-orientation.

#### Specific concerns include:

- 1. Withdrawal of Scale Fees for demonstrably spurious reasons.
- 2. The ARB controlling things they cannot possibly understand.
- 3. Design/Build contracts putting Contractor before Designer.
- 4. Eroding the architect's legal position in Standard Appointment.
- 5. A Plan of Work that undermines primacy and continuity in the Architect/Client relationship.

The RIBA is supposed to emphasise Architecture, by administering a system to facilitate great buildings for the long term public gain... in contrast to short sighted political agendas. It is not supposed to be a closed shop trade union. Exceptional distinguished designers should be invited to join the RIBA on merit regardless of academic credentials or ARB opprobrium.

Whilst planning policy increasingly emphasises "Design", it believes it to be a matter for public taste; circumventing the obvious professionals who live and breathe design throughout many years of education and experience in our field. Architect led design panels should be required of all planning authorities.

#### Architecture Education/Mental Wellbeing (A True Story)

In 1996 during my degree program, I became aware of the sad experience of another architecture student. He had been awake for 36 hours grinding at his design to avoid yet another bad crit. Feeling disoriented as he hadn't resolved his design problem, he went in search of an open food store - Christmas holiday period. With little money and no support, he risked starvation. He couldn't afford materials for his model - a requirement by the college who seemed uncaring about my student friend's welfare. Overwhelmed, he curled up and wept.

Fast forward to 2017 to 2019, my interaction with students in the UK mirrors this story, with mental health impacts such as depression. Moved, I initiated a research programme with University students. I was honoured to be recognised by RIBA during the Black History Month 2018. My findings corroborated the RIBA 2018 and similar studies. I now fund an initiative to support and mentor students, presented to RIBA Architects for Change (AfC) and in discussions with 3 Universities. Action is urgently needed in the entire educational system to reduce student stress levels while improving the quality of their education. I intend to fight for this as a council member if you decide.

#### Listening to RIBA Members

During past campaigns it became clear to me from phone conversations and letters that many members are unhappy. This is reflected in the low voting statistics and I am passionate to do whatever I can - within or outside the council to connect positively with other members. This has led to my relentless efforts to reach out to sympathetic council members, so we can achieve this goal together. I believe change can be achieved from within RIBA.

Again, you decide. Members voices must be heard and their concerns addressed.

Our young architects are not well prepared for life in practice. We should be encouraging them to address real life issues working alongside other disciplines; this will safeguard the future of our industry as we grapple with these big issues.

As an active member of my community and self-build enthusiast, I want to empower the public to feel more engaged with their built environment. I also want to help turn the growing tide of homelessness. I take a participatory approach and feel that the best form of leadership is through mutuality.

I would be honored to serve on the RIBA council and would take pride in helping to develop the industry that I am passionate about, and believe is integral to our society.
