# RIBA PEDR Monitoring includes

- Official monitoring of experience towards your Part 3
- Professional studies advice
- Monitoring of 12 months practical experience on 4/5 PEDR sheets
- Mentor guidance (if required)

### Background

The RIBA PEDR is a mandatory component of the RIBA Examination in Professional Practice and Management (Part 3).

RIBA Professional Experience Regulations require students presenting for the RIBA Part 3 oral examination stage to have recently completed a minimum of 24 months practical experience under the direct supervision of a professional working in the construction industry, which should include at least 12months working in the EEA, Channel Islands or the Isle of Man, under the direct supervision of an architect.

- Students undertaking their year out between Part 1 and Part 2
- Part 2 graduates who have not yet started a Part 3 programme.
- Graduates of overseas courses

Please complete the application form in block capitals and return it to the RIBA via email.

On receipt of your application form, the RIBA will review within two weeks and then invoice you for the PEDR monitoring fee.

Following successful payment, candidates will then receive a confirmation email of registration with the monitoring service, which will include information about the service, contact details for your Professional Studies Advisors and office mentor guidance.
